

GENERAL TERMS AND CONDITIONS

Registrations

The dance school « BE A DANCER » deliver a registration form onlign on its website that all parents of students must fill in and sign in order to confirm the child registration.

This signed form is the proof of the commitment from registrated students to follow strictly the dance classes for the chosen speciality and all along the scholar period (since September to June).

In return, the school is committed to teach dance classes all along the period above mentionned

The dance school » BE A DANCER » close during holidays scholar periods and days off. No courses are provided on this period.

Pre-registrations begins in May and closes at the beginning of July.

The registrations are definitely complete in mid-October. Nevertheless, it's still possible to register during current year subject to available places for the chosen speciality.

The student is respectfully requested to observe all the commitement period for the current year except in a case of force majeure (long-term sickness, move etc.) Then, there would be possible to cancel the registration only at the end of the current trimester on request to the school director by mail.

The registration will be entirely confirm only after the first payment of the courses. If the school doesn't receive the payment before the first course, the place of the student won't be guaranteed for the chosen course.

Registrations onlign on the school website is like a definitive registration. Only adults (legal tutors/parents) can fill in the registration form onlign and sign it.

The « BE A DANCER » school decline any responsability due to use its website and any damages arrived during the registration onlign.

Rates and subscriptions

Dance courses rates are as follows regardless the speciality :

1 hour course / week : 80 CHF / month => 800 CHF / year

3/4 hour course / week : 70 CHF / month => 700 CHF / year

Rates are calculated on a yearly flat-rate basis divided on the period from September to June including school holidays and days off, those last are not deductibles of the rate.

Discounted fares for families : 1 hour course / week : 2 children = 150 CHF / month
=> 1500 CHF / year

¾ hour course / week : 2 children = 130 CHF / month => 1300 CHF / year

1 hour course / week + ¾ hour course / week : 2 children = 140 CHF / month =>
1400 CHF / year

Beyond two children = special rates are granted for members of the same family. The « BE A DANCER » school also propose a subscription in the form of cards of 5 or 10 courses in order to permit to the student to come and test the dance class for a longer period. The card would be valid only for a trimester period. It is nominative and non-refundable (except case of force majeure : accidents, long-term sickness, move etc.) (cf : repayment terms below).

The rates for the card of 5 or 10 courses are as follows regardless the speciality :

One card of 5 courses = 125 CHF

One card of 10 courses = 250 CHF

The payment of dance classes for the complete scholar year (September-June) must be paid by bank transfer (e-banking) or in cash directly to the school director before the first course of the year. In case you have difficulties to paid the totality of the courses for the year, it would be possible to facilitate the payment of the courses making two or three payments divided (the first in the beginning of September / the second in the beginning of October). It would be just asked to parents of students to specify it to the director of the dance school in the registration time.

The first trial course is free. Beyond one trial course, the next course will be paid 25 CHF.

The « BE A DANCER » dance school could modify its rates from year to year and commit to respect the same rates all along one scholar period complete.

The « BE A DANCER » dance school arrange a dance show each end of year in June for the students in order to put the children in « stage » situation and for the parents to see the progress of students made in the year.

A financial contribution will be asked to the parents and dedicated to the making of costumes or for the purchase of costumes (in the limit of 30CHF/child)

Courses

The dance classes are given by a teacher certified who commit to teach to students a quality of teaching. The dance teacher has the right to change the class of student if he judges that the level of the class is not appropriate for the student.

For all request to move from a class, the parents of students must talk upstream to the dance teacher of their child in order to find a solution appropriate and fulfilling.

The time and place of the dance classes are settled upstream by the dance school, there aren't any possibilities to modify the schedule during the current year.

The « BE A DANCER » dance school could cancel classes if the conditions of organisation are not met (insufficient number of students).

Absences

Each student must notify his absence to the dance school before the beginning of the class for the smooth functioning of the session and the respect of the others students.

The absences are not deductible of the courses rate and aren't refundable. If an absence last a long time in a case of force majeure and with receipts provided to the director of the school, it would may possible to make a partial refund of initial rate. (cf : refund conditions below)

In the case of the teacher would be absent, the dance school commit to notify and give the information to the students before the beginning of the class and postpone the missing course to a next date (holidays, days off).

Refunds

The « BE A DANCER » dance school allows a refund of the rate courses only under particular conditions

In the case of force majeure (move, accidents, long-term sickness, serious injuries) the dance school allows a refund of 50% of initial rate. The refund will be possible only with official receipts provided to the director of the school.

Insurances

Each student must have imperatively a valid personal insurance for the dance practice. The « BE A DANCER » dance school refuse any responsibility attending to the missing of this rule as well as the illness, the accidents, serious injuries arrived in the dance class time or in the show time. It's the same for all loss/robberies or

damages of any personal objects brought to the course by a student. It is strongly recommended not to let any value stuff in the changing rooms (examples: jewels, mobile, money, etc.) In the case of loss/robberies or damages, the school would not be responsible. It's also requested for the students and parents not to touch items on the premises or damage it. If any items belonging to the center « A fleur de Peau » is damaged during classes, it would be directly invoiced to the guilty parties.

Dissemination policy and publicity rights

Except the refusal from the parents or students, the « BE A DANCER » dance school keep the right to use fully and freely without return in the present or in the future, the images of students registred for publicity of the school and only for this aim, over any media support used. In the case of refusal, it's just asked to the parents to inform the director of the dance school.

Choreographies teached by the « BE A DANCER » school teacher as part of his courses are the property of the teacher and school. The copy and publication of his work are only allowed for a private and no-commercial use.

All students wanting to film or taking photos during the classes must ask permission to the teacher.

All personal data (informations, contact details, etc.) about parents and students will stay confidential and exclusively use for the organisation of the dance school.

Privacy policy

Pursuant to General Data Protection Regulation (RGPD) in the UE, the « BE A DANCER » dance school gives you its privacy policy. The « BE A DANCER » dance school collect personal data (names, surnames, postal and e-mail addresses, phone number) through the registration and contact form on the website school. The communication of those information is essential for the smooth running and the organisation of courses. Those data are absolutly not provided to others. The information gathered are used to improve the dance school services, to communicate its news and activity proposal. You can acces to those information whenever you want, check it, or cancel it on request by mail : contact.beadancer@gmail.com or you can just also tell it to the director of the dance school.

Rules of procedure

The students must be quiet by respect for the others and for the previous class. Outside of the dance studio (cloakroom, hallways, etc.), the students should not run in the establishment, not damage the premises made available for the school, tidy up and clean the changing room after class and put back a clean sanitary state into every parts of the premises used (toilet, cloakroom, studio).

The shoes and drink/food are not allowed in the dance studio. Students must bring their own water bottle and can drink during the break outside of the dance studio.

The students must have a good behaviour, respectfull to each other and vis-a-vis the teacher for the right mood into the dance group. None violent or irreverent behaviours or actions would be permitted under penalty of exclusion.

The students and parents must strictly observe the schedule and respect hour course defined by the dance school (for the respect to others students). All recurrent delay without just cause will need to be explain with the director of the dance school.

The parents must come and fetch their child to the class at the right time.

Mobile phones and others digital devices must be turned off for the whole course. Cigarettes are also strictly forbidden into the school.

A dress appropriate for the dance activity is required. All clothes which are not suitable won't be accept for the course (jeans, skirt, etc) Coats and tights, ballet slippers, leggings and sport clothing are allowed. Hair must be tied up with an elastic band. No chewing-gum is allowed during the whole course.
